CTC has adopted a face covering policy which will recommend/require the wearing of face coverings following CDC, PaDOH, and PDE recommendations, adjusted for local consideration. The school nurse and school administrators observe and correct face covering deficiencies among students and staff upon entry and frequently throughout the school day.
b.	Modifying facilities to allow for physical distancing (e.g. use of cohorts/podding).	CTC facilities have been expanded (classrooms added) to provide additional opportunities for social distancing. Distancing within classrooms and lab areas will be maintained to the maximum extent practical.

c.	Handwashing and respiratory etiquette.	Proper handwashing and coughing/sneezing etiquette are encouraged through extensive signage, a looped video message and personal intervention by school staff.
d.	Cleaning and maintaining healthy facilities, including improving ventilation.	Cleaning and disinfecting protocols have been established and implemented and will continue as recommended/required by CDC, PaDOH, and PDE.
e.	Contact tracing in combination with isolation and quarantine, in collaboration with the State and local health departments.	Contact tracing, isolation and quarantine protocols will continue to be implemented in accordance with CDC, PaDOH, and PDE guidance, adjusted for local considerations.

Diagnostic testing utilizing rapid tests may be used to alter quarantine requirements for close contacts who are potentially exposed to positive cases, a practice referred to as "Test to Stay." Quarantine requirements will be followed based on CDC, PaDOH, and PDE guidance, adjusted for local considerations.
g.	Efforts to provide vaccinations to school communities.	Due to transportation issues, CTC was not able to provide vaccination opportunities to students. All staff have been offered opportunities to be vaccinated.

Individual student needs with regard to COVID- 19 and health and safety concerns will be addressed on a case-by-case basis dependent upon the need and accommodation(s) requested consistent with in-person instruction.
